Housing Now: A Vision to Reach Functional Zero Unsheltered Homelessness



Colleagues and friends,

Welcome to the **Third Annual Ending Street Homelessness Summit**. For three years now, we have gathered at this summit to examine the complex, systemic drivers of homelessness like rising housing costs, behavioral health and addiction crises, gaps in care, and a fragmented policy landscape. Each year, we've advanced the conversation, listened to a range of voices, and deepened our collective understanding of what it will take to end homelessness in California.

This year, I have chosen to focus specifically on unsheltered street homelessness—the most visible, traumatic, and deadly expression of our housing crisis. The numbers are striking and demand our attention. More than 180,000 Californians are experiencing homelessness, and the majority of them are living outside in tents, in cars, or on sidewalks. This is unacceptable in the world's fourth largest economy. In the last decade, over 50,000 people have died nationwide while living unsheltered. Allowing people to languish and die outdoors is not progressive, it's neglect.

We also know that this crisis is solvable. If we expand our understanding of what housing can be and if we prioritize **housing now** we can bring people indoors quickly, affordably, and humanely.

This year's summit explores that path forward. Cities like San José, for example, are showing what's possible by rapidly deploying interim housing using modular cabins on vacant land, supported by on-site services. These units are not the shelters of the past—they are secure, private, and scalable. They represent a middle ground between the street and permanent housing, and a lifeline for people currently waiting years for their forever home. Other cities, like San Diego, deploy safe sleeping and safe parking sites where services are co-located to connect individuals with the support they need.

Our current funding structures and regulations have not laid a path forward for **housing now**. Too often, state dollars are restricted to permanent housing only, excluding the very tools that can most quickly help people and end unsheltered homelessness.

This year, I authored **Senate Bill 16** to require California and its regions to plan and be accountable for reaching functional zero in unsheltered homelessness—meaning we have a system in place to consistently house people faster than new people enter homelessness. I remain committed to advancing unsheltered homelessness legislation until we solve this crisis.

This summit brings together local and state leaders to confront these challenges with urgency and hope. It is a call to act with clarity of purpose and with a willingness to do things differently.

Our policies must match the scale and immediacy of the crisis. This matters deeply to me, not just as a policymaker but as a human being who believes that no one should have to live and die on the streets. Thank you for being here today. Together we can—and must—do better.

The State of Homelessness in California

To open the summit, California State Senator Catherine S. Blakespear (D-38) and the State's Business, Consumer Services, and Housing Agency Deputy Secretary of Homelessness Dhakshike Wickrema, will offer a candid look at the state of homelessness and unsheltered homelessness in California. Deputy Secretary Wickrema will bring a big-picture perspective on how policy, funding, implementation, and coordination need to align to drive real progress. Together, they will demonstrate that there is hope and a clear path forward – to help people move off the streets and into safe, stable housing. Drawing on her firsthand experience shaping policy in Sacramento, Senator Blakespear will unpack the challenges and outline a vision for the bold actions needed to build real momentum for change.

Dhakshike WickremaDeputy Secretary of Homelessness
Business, Consumer Services,
and Housing Agency

Dhakshike Wickrema was appointed Deputy Secretary of Homelessness at the Business, Consumer Services, and Housing Agency by Governor Newsom

in March 2022. She previously served as Senior Deputy for Homelessness and Housing in Los Angeles City Council District 10, and as Senior Deputy for Homelessness and Mental Health in Los Angeles County Supervisorial District 2, where she supported efforts in 2017 to pass Measure H, which funds housing and homelessness services. She also worked at Shelter Partnership, a nonprofit focused on homelessness and affordable housing policy, and for the World Bank's Poverty Alleviation, Health Services, and Social Development sectors. She earned a Master of City Planning from MIT.

Elizabeth Funk is the Founder and CEO of DignityMoves, a nonprofit ending unsheltered homelessness through systems change and innovative, scalable solutions. Elizabeth was an early technology pioneer, on the founding team of Microsoft Word

and Office. As one of the first employees of Yahoo!, she oversaw the creation of Yahoo! Shopping, Finance, Travel, and other groundbreaking innovations. For nearly two decades, Elizabeth has been a prominent leader in the impact investing movement, leading funds addressing global poverty through microfinance, low-income housing, and environmental sustainability.

Elizabeth holds an honors degree from Stanford and graduated as a Baker Scholar from Harvard Business School.

Katie MelendezDeputy Mayor and Councilmember,
City of Vista, District 3

Katie Melendez serves as Deputy Mayor of the City of Vista and Chairwoman of the Homelessness Standing Committee. She brings years of experience in housing policy, public health, community advocacy and

has shaped Vista's award-winning Strategic Plan to Address Homelessness. Born and raised in Vista, she is deeply committed to advancing local solutions to homelessness that center on dignity, prevention, and long-term stability. Deputy Mayor Melendez has initiated life-saving programs such as Vista's first Permanent Supportive Housing for homeless seniors, safe parking program, rental assistance program, and more. In 2023, Deputy Mayor Melendez partnered with Senator Catherine S. Blakespear to open Vista's dignified, non-congregate shelter model.



Stephen WhitburnSan Diego City Council, District 3

Councilmember Stephen Whitburn represents San Diego City Council District 3. He serves as Chair of the City's Active Transportation and Infrastructure Committee, Vice Chair of the Audit Committee, and member of the Public

Safety Committee. He also serves as Chair of the Metropolitan Transit System (MTS) Board of Directors and Chair of the San Diego County Local Agency Formation Commission (LAFCO). Councilmember Whitburn is a member of the San Diego County Water Authority and the Regional Task Force on Homelessness Continuum of Care Advisory Board. Addressing the City's homelessness and affordable housing crises are top priorities for the Councilmember.

Summer StephanSan Diego County District Attorney

San Diego County District Attorney Summer Stephan is a nationally recognized leader in public safety, known for her work combatting human trafficking, protecting victims, and

championing justice reform. Elected in 2018 and reelected in 2022, she leads the second-largest district attorney's office in California, serving over three million residents. A seasoned prosecutor, she has tried more than 100 jury trials and pioneered San Diego's Sex Crimes and Human Trafficking Division. Under her leadership, the office has expanded victim services, tested over 2,000 rape kits, launched juvenile diversion programs, and increased prosecutions of hate crimes and fentanyl dealers. She also serves as the Chairwoman of the National District Attorneys Association and holds numerous state and national public safety leadership roles.

Todd Gloria Mayor, City of San Diego

Todd Gloria was sworn in as San Diego's 37th Mayor in 2020. He was reelected for a second term in November 2024. A third-generation San Diegan, he is the first person of color and the first LGBTQ person

to ever be elected as the city's Mayor. Inspired by his parents – a hotel maid and a gardener – he entered public service to leave things better than he found them. He was elected to the City Council in 2008. He served as City Council President, and Interim Mayor in 2013. In 2016, Mayor Gloria was elected to the California State Assembly to represent the 78th Assembly District. Mayor Gloria is a graduate of the University of San Diego.



Matt Mahan Mayor, City of San José

Matt Mahan is the 66th Mayor of San Jose. He previously served as a teacher through Teach for America before entering the business world, where he founded and grew companies dedicated to empowering

neighborhoods and holding our government accountable. These core tenets remain key to his policy priorities as he pledges to focus city government on the basic quality of life issues that impact us every single day. He currently resides in San José with his wife, Silvia, and their two children.




Monica Montgomery SteppeSan Diego County Supervisor, District 4

Supervisor Monica Montgomery Steppe is the first Black woman elected to the San Diego County Board of Supervisors, representing District 4. A San Diego native, she leads with a deep commitment

to equity, racial justice, housing, and behavioral health reform. Since taking office in 2023, she has advanced oversight of law enforcement, supported reparations, and expanded initiatives focused on homelessness and food access. With over a decade of experience in law and policy, including service on the San Diego City Council, she brings a justice-centered, community-first approach. She holds degrees from Spelman College and California Western School of Law.
